Curriculum Vitae

Born in Naples on 14 October 1967, graduated in 1991 in law from the University of Rome, "La Sapienza", with a thesis entitled "The CONSOB and Its Evolution" under the tutelage of Prof. Bernardino Libonati, with a score of 110 with honors.

Worked as a lawyer in the offices of Prof. Bernardino Libonati until 2006. A registered member of the Council of the Bar Association in Rome since 8 August 1994. Since 10 March 2001, authorized to appear before the Supreme Court and other high courts.

Commercial Law Researcher in the Law Faculty of the University of Urbino from 1996 to 1998, before coming an Associate Professor from November 1998 and assuming a position teaching commercial law in the Economics Faculty of the University of Florence, remaining until 31 October 2004. Also, within the Economics Faculty at the University of Florence, taught Insurance Law for a three year period from 1998-2000. Tenured Professor since 1 November 2000, from 1 November 2004 became Professor of Commercial Law in the Law Faculty of the University of Naples "Federico II" and continues to be a member of the faculty. At the l'Ateneo federiciano assumed an additional role as an Adjunct Professor over the years teaching insurance law, industrial law and maritime law.

Covered, in the past, important roles within the board of directors of publicly listed companies, including, in particular, at Assicurazioni Generali. By nomination from the Bank of Italy, was part of the oversight committee of the Banca delle Marche S.p.a. in receivership, and of Medio Leasing S.p.A. in receivership

From 1 October 2009 until 5 October 2015, was a member designated by Confindustria of the Arbitro Bancario Finanziario (collegio di Napoli), alternative dispute resolution body instituted by the Bank of Italy for the extrajudicial resolution of banking disputes. From 19 December 2016 he was a member, nominated by the Association of Intermediaries (Assogestioni and

ABI), of the Arbitration of the Financial Disputes, body instituted by CONSOB per the extrajudicial resolution for disputes in investment services.

He is a member of the editorial board of the following legal publications: *Rivista del Diritto Commerciale*, di *RdS-Rivista del Diritto Societario*, of the *Osservatorio di Diritto Civile e Commerciale*, and the *Corriere Giuridico*. He is author of four monographs: *Gestione Rappresentativa e Attività di Impresa* (Padua, 1997) *Il Titolo Azionario Come Strumento di Legittimazione. La Finanziario* (Milan, 2000); *Il Mercato Concorrenziale: Problems and Conflicts* (Milan, 2010) *Gestione dell'Impresa e Interferenze di Interessi. Trasparenza, Ponderazione e Imparzialità nell'Amministrazione delle s.p.a.* (Milano, 2014); and author of more than 100 article published in the main law journals, in terms of companies, businesses, bankruptcy, competition, bank and financial markets.

From 2007, maintain an ongoing relationship with Spanish Universities, in particular those in Valencia, where in 2012 he was a visiting professor.
